- III. The Minutes from the January and June meetings were approved.
- IV. The Treasurer's Report was presented and approved. Year-to-date income as of 30 June 2020 totaled \$465,174.00 and Y-T-D expenditures totaled \$445,005.00.

- VI. The Director's Report was given by Director Chandra McPherson and accepted by the Trustees. During the shutdown, staff completed the first full inventory of the collection in a decade. Utilizing a grant from the National Institute of Health, a "laptop lab" has been purchased and set up. Windfall monies from E-Rate were used to purchase a long range wifi booster. Chandra has been working on lining up hosts for the library's wifi repeaters. HPL is partnering with an organization called From the Heart to produce protective face masks for students. C&F Bank is waiting for additional federal paperwork for the Payroll Protection Program (PPP) funds the library received this will convert the money into a grant that will not require repayment.
