Minutes of the Meeting of the Heritage Public Library
Board of Trustees

July 17, 2023

- I. Call to Order: Chair called the regular quarterly meeting to order at 7:00 p.m.
- II. **Approval of Agenda:** Motion was made by Jay Templin, seconded by Chris Matthies, and unanimously approved to accept the agenda as presented.
- III. **Approval of Minutes:** A motion was made by Victoria Brame, seconded by Chris Matthies, and unanimously approved to accept the minutes of the April 17, 2023 meeting.
- IV. **Treasurer's Report:** Jesse Kelly presented the Treasurer's report for fiscal year ending June 30, 2023. Income from processing passports was better than projected. More libraries are offering this service and postage fees are increasing so this may impact future revenue. Utilities increased slightly in FY23. The Director reviewed the proposed FY24 budget and

noted that additional funds have been budgeted for postage expenses in FY24. Chris Matthies made a motion to accept the proposed FY24 budget. It was seconded by Victoria Brame and unanimously passed.

- V. Citizen's Comment Period: There were no public comments.
- VI. **Director's Report:** The Director shared his goals for FY24 which include:
 - A 3% cost of living increase for library staff.
 - Increase new patrons by offering new and different programs with a small increase to the programming budget.
 - Engage in community events.

The Director discussed the addition of HOOPLA, a digital resource offering movies, e-audio, music and other e-resources. This is in addition to the resources offered through the Libby app.

The Director will be exploring reforming the Friends of Heritage Public Library group and identifying their purpose.

The Library of Virginia will pay for training on the new ILS, Atriuum. This is scheduled for August 30 and 31, 2023. Both branches will be closed so that all staff can attend.

A \$6,000 grant was awarded to provide basic computer literacy courses. Parks and Rec plan to help with getting word out. The courses may be geared towards seniors in our community. The courses will begin in the fall and must be finished by the first of the year.
