- 1. Call to Order: The meeting was called to order by the Chair at 7:00 pm.
- II. A motion was made by Kim Moyer, seconded by Victoria Brame, to accept the agenda.
- III. Jay Templin motioned, Chris Matthies seconded, to accept the minutes.
- The Treasurer's Report was presented by Interim Director, Janet Woody
 - The library budget is on track for FY 2023-2024.
 - b. There is a decrease in passport revenue due to low staffing.
- ٧. Citizen's Comments: John Moyer, NK District 2 BOS, expressed appreciation for the Board and all library services.
- VI. Director's Report: Interim Director Janet Woody provided an update of programs and activities attended in November and December, 2023. Ms. Woody recommended an increase in funding, approximately 5%, to elevate the position vacated by Ms. Kendra Mathis to a full time Assistant Director. She suggested this position oversee collections as well as supervise the circulation staff. Ms. Woody also indicated in her report that the annual Bibliostat report would be due soon; thus, she would create a training document for the new director prior to her last day.
- VII. New Business: Jane Copeland will join the board as the Charles City County District 3 representative.
